



"PRIVACY DISCLAIMER"

Information document pursuant to Article 13 of EU Reg. 2016/679 (GDPR) – *Information for the processing of personal data collected from the interested party*

In compliance with the provisions of EU Regulation 2016/679 (European Regulation for the protection of personal data), the necessary information is provided regarding the processing of the personal data provided.

Definitions: the art. 4 of EU Reg. 2016/679 defines "personal data" as any information relating to an identified or identifiable natural person ("interested party"); an identifiable natural person is one who can be identified, directly or indirectly, in particular by reference to an identifier such as a name, an identification number, location data, an online identifier or to one or more elements characteristic of his physical identity, physiological, genetic, psychological, economic, cultural or social.

1) DATA CONTROLLER

Pursuant to art. 4 of EU Reg. 2016/679, is the 100Km del Passatore Amateur Sports Association, with headquarters in Via Santa Maria dell'Angelo n. 7, 48018 Faenza (Ra), and the person responsible for decisions on treatment is Mr. Giordano Zinzani as legal representative.

2) PURPOSE AND LEGAL BASIS OF THE PROCESSING

The personal data provided will be processed for the following purposes in compliance with the appropriate conditions of lawfulness pursuant to art. 6 of EU Reg. 2016/679:

- navigation on this website: legitimate interest (art. 6 paragraph 1 letter f)) as the legal basis for the processing;
- filling in the data collection form for receiving newsletters or promotional communications generally via e-mail: consent (art. 6 paragraph 1 letter a)), until revoked by the interested party, as the legal basis for the processing;
- filling in the data collection form for registration to the sporting event and insertion of the personal data into the association's database: execution of the contract (art. 6 paragraph 1 letter b)), legitimate interest (art. 6 paragraph 1 letter f)) and consent (art. 6 paragraph 1 letter a)) if the data provided fall in whole or in part to the particular categories referred to in 9 paragraph 1 of EU Reg. 2016/679, as the legal bases of the processing.

3) RECIPIENTS OR CATEGORIES OF RECIPIENTS OF THE DATA

The personal data provided may be communicated to recipients, who will process the data as managers (art. 28 of EU Reg. 2016/679) and/or as natural persons acting under the authority of the Data Controller and the Responsible (art. 29 of EU Reg. 2016/679), for obligations related to the purposes listed above in point 2.

By way of example and not exhaustively, the data may be communicated to:

- subjects who provide services for the management of the information system used by the Data Controller and the related telecommunications networks, including e-mail, newsletters and website management;
- professionals, consultants and companies in the context of assistance, consultancy and provision of services in general;
- competent authorities for the fulfillment of legal obligations and/or provisions of public bodies, upon request.

The subjects belonging to the aforementioned categories perform the function of Data Processor, or operate in total autonomy as separate Data Controllers.

4) DATA TRANSFER TO A THIRD COUNTRY AND/OR AN INTERNATIONAL ORGANIZATION AND GUARANTEES

The personal data provided may be transferred to countries belonging to the European Union and to non-EU countries if necessary in order to comply with the purposes indicated above. The data will be transferred in compliance with the conditions set out in Chapter V – Transfers of personal data to third countries or international organizations – EU Reg. 2016/679; specifically, the data will be transferred to third countries or international organizations for which the Commission has intervened with an adequacy assessment (art. 45 EU Reg. 2016/679). The interested party will be able to obtain information about the actual transfer of data to a third country and the appropriate guarantees adopted so that the level of protection of data transfer is not compromised, by writing an email to info@100kmdelpassatore.it or to the registered office of the Data Controller of the processing at the headquarters in Via Santa Maria dell'Angelo n. 24, 48018 Faenza (Ra).



5) DATA CONSERVATION PERIOD OR CRITERIA FOR DETERMINING THE PERIOD

The processing will be carried out in an automated and manual manner, with methods and tools aimed at guaranteeing maximum security and confidentiality, by the owner and/or persons specifically appointed for this purpose.

In compliance with the provisions of the art. 5 paragraph 1 letter. e) of EU Reg. 2016/679, the personal data collected will be stored in a form that allows the identification of the interested parties for a period of time not exceeding the achievement of the purposes for which the personal data are processed. The storage of personal data provided depends on the purpose of the processing (the times have been determined on the basis of criteria on which the interested party can receive information by writing an email to info@100kmdelpassatore.it):

- browsing the website: see the provisions of the cookie policy;
- receipt of newsletters or promotional communications generally via e-mail: maximum 24 months;
- registration for the sporting event: maximum 12 months following the end of the event;
- insertion of the personal data into the association's database: the minimum time necessary to comply with the provisions of the Official Regulations of the event.

6) NATURE OF THE PROVISION OF DATA AND CONSEQUENCES OF THE REFUSAL TO PROVIDE THE DATA

Apart from what is specified for navigation data, the communication of personal data is not an obligation, as you are free to provide your personal data in the dedicated areas on the site, but it is necessary to fulfill the purposes of the processing; the consequence of failure to provide personal data makes it impossible to use the various services offered by the data controller.

7) RIGHTS OF INTERESTED PARTIES

The interested party may assert their rights as expressed by EU Regulation 2016/679 by contacting the Data Controller, sending an email to info@100kmdelpassatore.it or writing to the Data Controller's office indicated above.

The interested party has the right, at any time, to ask the Data Controller for access to his/her personal data (art. 15), rectification (art. 16) or cancellation (art. 17) of the same, limitation of the processing (art. 18), the portability of data (art. 20) or finally to oppose data processing based on legitimate interest (art. 21).

Pursuant to art. 7, paragraph 3, the interested party has the right to revoke the consent given at any time.

In the case of a request for data portability, the Data Controller will provide the data in a structured format, commonly used and readable by an automatic device without prejudice to paragraphs 3 and 4 of the art. 20 of EU Reg. 2016/679.

Without prejudice to any other administrative and jurisdictional appeal, if the interested party believes that the processing of data violates the provisions of EU Regulation 2016/679, the interested party has the right to lodge a complaint with the supervisory authority (Guarantor for the protection of personal data) pursuant to art. 15 letter f) of EU Reg. 2016/679.

8) AUTOMATED DECISION-MAKING PROCESSES
